

PRIVACY STATEMENT

SECTION 1 - WHAT DO WE DO WITH YOUR INFORMATION?

As part of the buying and selling process, we collect personal information you provide to us when you make a purchase from our website. This may include your name, address, and email address, among other details needed to process your transaction and deliver your order. We treat this information with the utmost care and take appropriate measures to ensure its protection in accordance with applicable data protection laws.

When you visit our website, we may also collect your computer's internet protocol (IP) address to gain insights into your browser and operating system. Additionally, we may send you emails regarding our store, new products, and other updates, but only with your consent.

SECTION 2 - CONSENT

How do you get my consent?

When you provide us with personal information to complete a transaction, verify your credit card, place an order, arrange for a delivery, or return a purchase, we imply that you consent to our collecting it and using it for that specific reason only. If we ask for your personal information for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

How do I withdraw my consent?

We may disclose your personal information if we are required by law to do so or if you violate our Terms of Service.

SECTION 4 - SHARING

We utilize external shipping and credit card processing companies to handle order fulfillment and payment processing. These companies are not permitted to use, share, or retain any personally identifiable information for any reason other than fulfilling your order. They are not authorized to use your personal information for any secondary purposes. We take every necessary measure to ensure the security and confidentiality of your personal information in accordance with applicable data protection laws.
